# **SECTION 4: First aid measures**

# 4.1. Description of first aid measures

# General information

In all cases of doubt, or when symptoms persist, seek medical advice. In case of unconsciousness give nothing by mouth, place in recovery position and seek medical advice.

# Following skin contact

If the eye is bonded closed, release eyelashes with warm water by covering with wet pad. Cyanoacrylate will bond to eye protein and will cause periods of weeping which will help to debond the adhesive. Keep eye covered until debonding is complete, usually within 1-3 days. Do not force eye open. Medical advice should be sought.

# Following ingestion

Ensure that breathing passages are not obstructed. The product will polymerise immediately in the mouth making it almost impossible to swallow. Saliva will slowly separate the solidified product from the mouth (several hours). If lips are accidentally stuck together apply warmwater to the lips and encourage maximum wetting and pressure from saliva inside the mouth. Peel or roll lips apart.
